

Producer Price Index in Iran

Tir 1386

(1376 = 100)

The Producer Price Index (**PPI**) went up 2.4 percent in Tir 1386. Showing the index point of 398.0, the **PPI** was 16.1 percent higher than the similar month in 1385.

During the first four months of the current Iranian year, the Producer Price Index rose 15.8 percent compared to the similar period in 1385.

The Producer Price Index increased 14.7 percent during the last twelve months leading to Tir 1386, compared with the similar preceding period.

In Tir, the agriculture, animal husbandry and forestry group index went up 1.9 percent, which was mainly attributed to the rise in the prices of barley, potatoes (domestic use), fruits with seeds and pits, live animals and honey. In this group, the prices of straw, exported pistachio and poultry declined.

The advance in the prices of the Persian Gulf fishes mainly caused 3.4 percent increase in the group index of fishing.

The mining and quarrying group index fell 0.3 percent.

The manufacturing group index went up 1.5 percent, which was mainly due to the increase in the prices of mutton, dairy products, bread, shoes, motor oil, exported sulfur, tires and tubes, tiles, bricks, asphalt, iron wire and iron belt, iron profile, black iron pipe, exported hot coil iron, copper and its products, steam boilers, electrodes, taps, burners, transformers, lamps and car oil filters. In this group, the prices of

chicken, hand-made carpets and rugs (domestic use), some products of aluminum and brake linings decreased.

The electricity, gas and water supply group index and the repairing of motor vehicles group index rose 0.5 percent and 1.3 percent, respectively.

The increase in the charge of hotels and inns mainly caused 2.6 percent advance in the group index of hotels and restaurants.

The transport, storage and communications group index went up 8.6 percent, which was mainly attributed to the rise in the prices of land transport and transport of passengers by foreign flights.

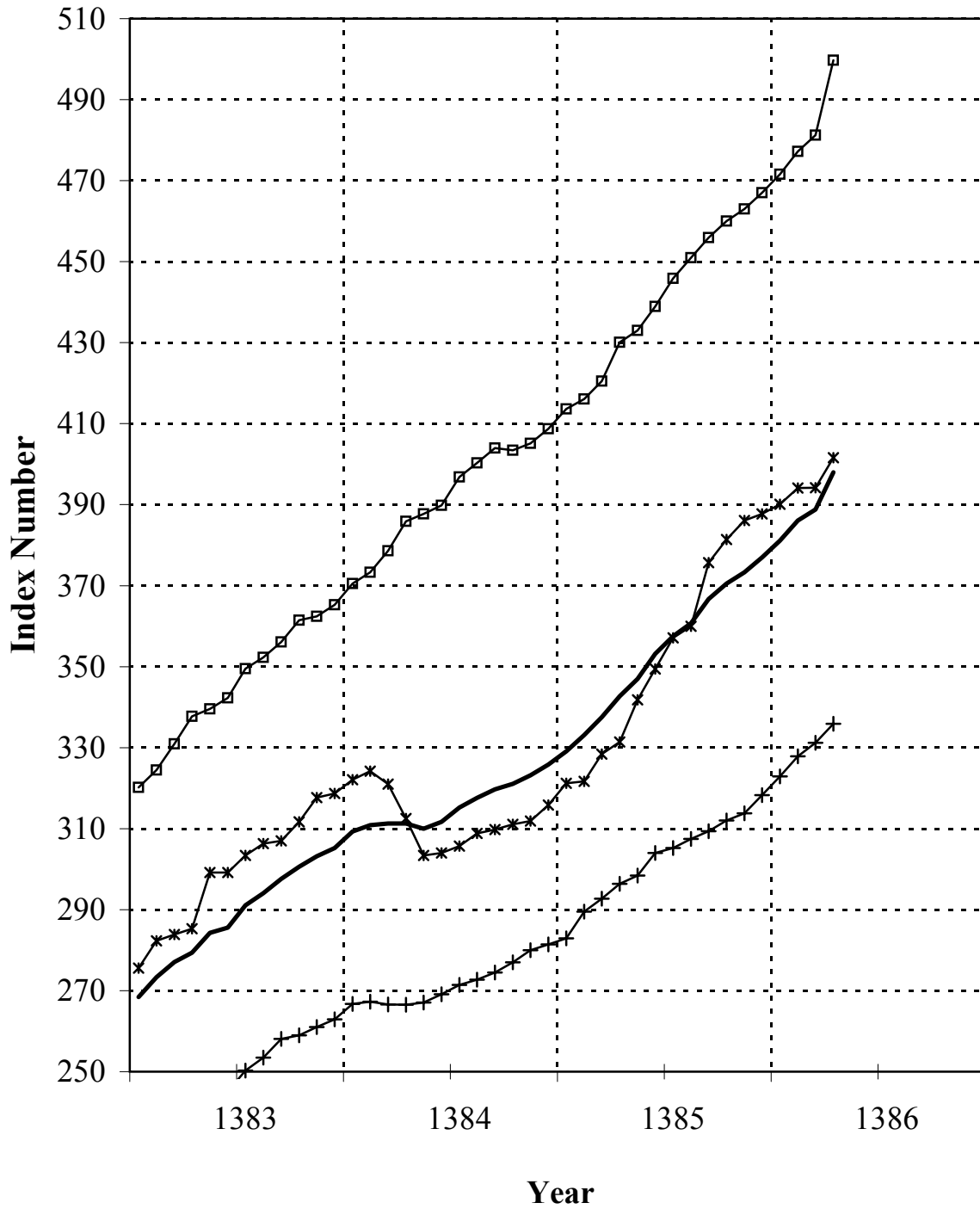
The financial intermediation group index increased 1.8 percent.

The advance in the prices of third party insurance and constructional services mainly caused 1.7 percent rise in the group index of real estate, renting and business activities.

The education group index had no change.

The health and social work group index and the other community, social and personal service activities group index went up 2.6 percent and 0.7 percent, respectively.
